

# **Application for Residential Tenancy**

# How long will it take to process my application?

Tenancy Applications will take 24 – 48 hours to process, pending the availability of the persons or companies you put down as references or emergency contacts. The application will then be presented to the property owner for their consideration and decision. You will be contacted as soon as we receive the property owner's decision on your application.

# How can I ensure my application is processed quickly?

If all the correct information and documentation is provided when handing in your application, it can be processed within 24 – 48 hours. Please ensure you have provided:

- All sections of the application have been completed and answered in full.
- You have read, understood and signed this cover page.
- You have signed the application on page 4.
- You have filled in and signed the Privacy Notice & Consent Page on page 5.
- You have provided all supporting documentation:
  - You have provided copies of your ID (totalling 100 points of ID as described in Item 13, page 3 of the attached application, ensuring that at least one piece of ID is photo ID.)
  - You have provided copies of your Proof of Income (as described in Item 14, page 3 of the application.)
- Item 11, page 3 Personal References; We recommend that you provide names, addresses and phone numbers of friends or colleagues who have known you for longer than 12 months, have visited your home, and can be contacted during business hours.
- If you receive any Centrelink or Family Assistance Payments, please ensure you include a recent Centrelink Statement. Centrelink Statements can be downloaded free of charge on the MyGov or Centrelink apps.

If questions have not been completed or supporting documentation has not been provided by the applicant, applications can exceed 48 hours processing time.

## Will Quaid Real Estate conduct a Tenancy Database Check?

Yes. Quaid Real Estate will use the TICA database and every application received is checked on this database. Applicants can visit the TICA database website for more information by visiting <a href="www.tica.com.au">www.tica.com.au</a>.

## How many applications do I/we need to complete?

Every person aged 18 years and over who intends to reside at the property must fill in an individual application form and provide supporting documentation. N.B. This includes the adult dependent children, relatives or live in friends of the applicants who will not be listed on the tenancy as the lease holders. They will be listed as approved occupants only, however the same documentation must be supplied.

Disclosing pets is not limited to cats and dogs. Reptiles, fish, birds or any other animal will need to be listed in Item 6 on page 1.
